You are invited to participate in a two-day international workshop on the implementation of the European Water Framework Directive (WFD) in relation with priority and emerging pollutants, organized by the University of Girona, in cooperation with the Catalan Institute for Water Research, the Catalan Water Agency, and United Research Services (Spain). This workshop will provide a link between the scientific research and the management practices aiming to evaluate the effects of pollution caused by emerging and priority pollutants and will allow researchers, water authorities and other stakeholders to present and discuss strategies to assess and manage environmental issues in European river systems.

The workshop will focus on the following major topics concerning priority and emerging pollutants:

- Sampling strategies and analytical procedures
- Search for key toxicants and transformation products
- Bioavailability
- New approaches to evaluate ecological integrity
- Applicability and limitations of biomarkers
- Experimental approaches to investigate the effects of priority and emerging pollutants in the environment
- Modelling aspects related to river management
- Recommendations for water managers
